## SELLERS/FOOD PERMIT

All vendors and exhibitors must have a valid California tax permit to participate in the Festival. The certificate must be available for inspection during the event. If you are selling any food items, you must have a Food and Health Permit.

## OPERATION OF EXHIBITS

Festival Management reserves the right to restrict the operation of, or evict completely, any exhibit, which, in its sole opinion, detracts from the general character of the festival as a whole. Sufficient space must be provided within the exhibit space for the comfort and safety of persons watching demonstrations and other promotional activities. Each exhibitor is responsible for keeping its exhibit space free of congestion caused by demonstrations or other promotions. No Food or Beverages may be served from your booth space without written permission from show management. Exhibitors may not serve alcoholic beverages.
